Reward offered in killing

A woman is offering a \$5,000 reward for information leading to the arrest and conviction of the killer of her husband in a west Houston bar.

Phillip Hayes Oliver, 41, of 3603 Abinger, was shot Jan. 11, 1985, at Bentley's, 64 Woodlake Square.

Oliver, who was doing carpentry work at the bar, was sitting at a table when struck by a shot fired from outside.

Authorities believe the shot was fired by a man twice kicked out of the bar that night. He has not been identified.

Anybody with information can call AAR Investigations Inc., a private firm investigating the case for Oliver's wife. Carol.

Murderer sentenced

A Harris County man has been sentenced to 15 years and a day in prison after pleading guilty to the shooting death of Earl Horn.

Samuel Espino, 43, was sentenced Monday in state District Judge Albert Pruett's court. Espino had been scheduled for trial in the deaths of Horn, 60, and Patricia Haney, 26.

Prosecutor Lee Coffee said the charge involving Haney's death was dropped because of a lack of evidence. The extra day in Espino's sentence will prevent his being freed on bond if the case is appealed.

Area man suing Saudis

A Houston man who says he was tortured and abused for 2 1/2 years in a Saudi Arabian prison is suing three Saudi princes and several U.S. corporations for undisclosed damages.

Keith Carmichael and his company, Sacem International, filed a lawsuit in federal court Monday against Saudi Investment Group and Marketing, United Technology Corp., United Technology Saudi Arabia and Price Waterhouse accounting firm, among others.

Carmichael says he was falsely imprisoned in Saudi Arabia in 1981 over a business dispute and was released only after King Faud overruled other family members.

The lawsuit says the action violated international covenants and laws.

Doctor makes settlement

A local physician made a \$300,000 settlement with a Pasadena couple whose daughter died of cancer despite his claimed drug cure produced from human urine.

Stanley and Bernice Zabodyn settled their lawsuit against Dr. Stanislaw R. Burzynski, scheduled for trial Monday, to prevent reliving the painful death of their daughter, Kay Wimberley, 24, said their attorney, John R. Leach.

The family took their daughter, suffering from Ewings sarcoma, to Burzynski's clinic at 6221 Corporate in February 1982 to receive treatment using what he described as an antineoplastin drug derived from human urine.

She died two months later. The Zabodyns claimed the treatment increased her pain and hastened her death.

Since 1983, the U.S. Food and Drug Administration has investigated Burzynski for allegedly failing to conduct animal testing with his drugs and transporting the medication out of state. Burzynski filed a counterclaim, and a judge ruled that misleading statements had been made against the doctor.

Minister ordered jailed

ORANGE - The former youth minister of a Bridge City church is spending three weeks in jail after a judge found that he violated terms of the probation he received after being convicted of killing his wife.

State District Judge David Dunn last week ordered the Rev. Michael Haley, 33, to spend 21 days in the Orange County Jail for failing to make several \$50 payments on a fine and probation costs. Haley, former youth minister for Bridge City's First Baptist Church, was serving a 10-year probation after pleading guilty to manslaughter in the October 1982 death of his wife, Dorothy. Haley is now a minister in New York state.

Blood matches woman's

CONROE - Blood found in the apartment of Etta Ann Urdiales matches that of the missing Conroe paramedic, lab tests show.

Conroe police spokesman Rodney Meadows said the Department of Public Safety has confirmed that blood found on Urdiales's nightclothes, bedroom floor and bathroom counter top is the same type as that of the woman who has been missing 11 days.

He said police are continuing to investigate several leads in the case. The woman's parents have offered a \$5,000 reward for information leading to the discovery of their daughter.

Urdiales, 25, of 800 Bellshire Drive, was reportedly last seen by co-workers Feb. 21 when she left her shift at Emergency Medical Services.
